

Noosa Outrigger Canoe Club Raffle 2022

The Noosa Outrigger Canoe Club is a local, not for profit community club passionate about the sport of outrigger canoeing. The club encourages people from 8 to 88 years of age to stay fit, healthy and socially connected in an environmentally friendly way. The club is conducting a raffle to raise funds to purchase equipment to support our growing and vibrant club such as an additional racing canoe at a cost of \$32,000.

The Prize

One lucky business owner will have their business logo on a Noosa Outrigger Canoe Club racing canoe for a period of 3 years, valued at an estimated \$7,500. The size of the logo will be 2000mm wide by 400mm high and will be located on both sides of the hull of the canoe.

After 3 years, the winner has the option to continue to have their logo displayed on the canoe at a cost of \$1,000 per year.

This canoe will be raced in outrigger canoeing competitions all over Queensland and Australia. In addition, the lucky winner will receive regular business exposure on the Noosa River as the Noosa Outrigger Canoe club members train in their sponsored canoe.

Terms and Conditions

This Raffle is run by Noosa Outrigger Canoe Club of Chaplin Park, Gympie Terrace, Noosaville, 4566 QLD (ABN 99 391 029 730).

1. The total number of tickets in the raffle is 375 and the price of each ticket is \$100. The total number of prizes is 1.
2. Information on how to enter forms part of the terms and conditions of entry.
3. Purchase of a raffle ticket is deemed acceptance of these Terms and Conditions.
4. Anyone under the age of 18 are ineligible to purchase raffle tickets.
5. Entrants must specify their contact details in the section provided on the ticket stubs.
6. Incomplete or incomprehensible entries will be ineligible. Complete entries will include a first and last name, a telephone number and/or email address at a minimum.
7. Entrants are not restricted or limited to the number of raffle tickets which may be purchased.
8. Raffle ticket sales will conclude on 31 August 2022 at 11:59pm (AEST).
9. The draw for the winner will take place on 7 September 2022 at 10:00am (AEST), at Chaplin Park, Noosaville.
10. The winner will be notified by phone or email within 2 days of the draw and the result published on the Club's website (www.noosaoutriggers.com.au) on 9 September.
11. Entrants need not be present to win. Prizes cannot be transferred or redeemed for cash.
12. The prize will be delivered upon finalisation of the logo design and application to the canoe. The winner therefore agrees that the prize may not be delivered immediately after the draw.
13. Signage costs will be covered by the Noosa Outrigger Canoe Club.
14. The winner will be required to approve the logo graphics before they are applied to the canoe.
15. Noosa Outrigger Canoe Club reserves the right to request the winner to submit their ticket stub as proof of identity and purchase. Proof of identification and entry considered suitable for verification is at the discretion of Noosa Outrigger Canoe Club.
16. The Prize winner is advised that tax implications may arise from their prize winnings and they should seek independent financial advice prior to the acceptance of the prize.
17. If for any reason the raffle is not capable of running as planned, including (but not limited to) tampering or any other causes beyond the control of Noosa Outrigger Canoe Club, which corrupt or affect the administration security, fairness or integrity or proper conduct of the

raffle, Noosa Outrigger Canoe Club reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, take any action that may be available, and to cancel, terminate, modify or suspend the raffle, subject to any direction given under state permit regulations.

In the case of the intervention of any outside agent or event which naturally changes the result or prevents or hinders its determination, including but not limited to vandalism, power failures, tempests, natural disasters, acts of God, civil unrest, strikes; Noosa Outrigger Canoe Club may in its absolute discretion cancel the event and recommence it from the start on the same conditions subject to state legislation.
19. The Noosa Outrigger Canoe Club will not be liable for any loss or damage whatsoever which is suffered (including but not limited to direct or consequential loss) or sustained in connection with any prize/s, except for any liability which cannot be excluded by law.
20. If any prizes remain unclaimed for 1 year, Noosa Outrigger Canoe Club will deal with such prizes in accordance with the law.
